It is preferable but not mandatory that they are CPHS 1
8. **Level 1 Applicants ONLY**
At least one Hydrographic Survey Report conducted in the past 24 months. If applying for recertification in Sub-Specialism/s, one Survey Report relevant to each Sub-Specialism applied for.
9. **Level 1 Applicants ONLY**
Hydrographic Survey Plan/s (i.e. fair sheet / smooth sheet / drawings) for the above Hydrographic Survey Report/s.
